

Ron Hunter's Dive Expeditions (Lormine Pty Ltd)

Terms & Conditions

If it becomes necessary to cancel your holiday, you must notify Ron Hunter's Dive Expeditions (Lormine Pty Ltd) immediately in writing. Cancellation will take effect upon receipt and acknowledgement of your cancellation. Cancellations fees apply as following:

- More than 60 days Loss of deposit and any progress payments
- 59-31 days minimum 50% of the total cost of the package
- 30 days or less No refund

Final payment is due 60 days prior to event start date or as indicated in the event itinerary.

INSURANCE

Travel Insurance is compulsory and forms part of our booking conditions. Ron Hunter's Dive Expeditions (Lormine Pty Ltd) strongly suggests that you take out Travel Insurance at the time of paying your deposit. Travel Insurance with our recommended companies, Toursafe Australia or Covermore cover you for unforeseen contingencies for up to two years, from the date of taking out their insurance, through to the date that you return from your tour. Check the wording and conditions of the policy document for inclusions and exceptions.

The most common claim on Travel Insurance is for loss of payments made due to unforeseen illness or injury to a close family member, which has caused the traveller to cancel their trip.

OTHER INFORMATION

Usually prices are quoted in Australian dollars (\$AUD) unless otherwise notified. The expedition itinerary and price is subject to change due to unforeseen circumstances, such as, but not limited to alterations to supplier's charges, fuel levies, and currency exchange fluctuations, The expedition itinerary is also subject to change due to unforeseen circumstances or as deemed by Ron Hunter's Dive Expeditions (Lormine Pty Ltd) or your guide. Please note that we work on a "personal responsibility" system with all aspects of our events. The sheer nature of travelling, outdoor locations, new countries or locations has some risks. Please read "Responsibilities" for further details

INCLUDED IN YOUR PACKAGE

As per your travel itinerary - On some tours international and domestic airfares, airport and airline taxes are included. Usually included are, transfers and some meals, land and water transport, entrance fees, accommodation on a twin-share basis, single supplement is usually available, or we will endeavour to organise same gender room buddies. Check your tour itinerary.

NOT INCLUDED IN YOUR PACKAGE

As per your travel itinerary, alcoholic beverages and wine, laundry, tips to local staff and travel insurance. On some tours airfares and taxes are not included. Check your tour itinerary.

MINIMUM NUMBERS

All events are based on a minimum of 4 participants.

SCUBA DIVING TOURS

Most of our SCUBA dives whilst on tour are easy to moderate. It is the responsibility of participants to assess their ability level and suitability for any given dive site and it's prevailing conditions on the day, and confer with the guide(s) and Divemasters if you perceive a possible problem arising. We suggest that you get out and undertake a few deeper dives before departure. This will allow your holiday to be more enjoyable

SNORKELING TOURS

All of our snorkeling tours are easy to moderate. It is the responsibility of participants to assess their ability level and suitability for any given snorkeling site and it's prevailing conditions on the day and confer with the guide if problems arise. We suggest that you get out and do as much open water (ocean) snorkeling as possible before departure. This will allow your holiday to be more enjoyable. Your guides are all PADI professionals, Diving Instructors and Divemasters

MEDICAL

If you have any medical conditions - please advise Ron Hunter's Dive Expeditions (Lormine Pty Ltd) with your booking form. While a travel medical kit and supplies will be suggested to you to bring with you, please bring your own extra medication if required. (Details are confidential.)

PASSPORTS (For overseas expeditions.)

Passports with a minimum 6 months validity on your return date into Australia are required. Please check visa requirements. Ron Hunter's Dive Expeditions (Lormine Pty Ltd) takes no responsibility for passports or visa's.

RESPONSIBILITY (Please read carefully.)

Your booking is only valid with Ron Hunter's Dive Expeditions (Lormine Pty Ltd) receiving a signed and completed Travel Booking Form.

By my signature as set forth on the booking form I also acknowledge and confirm the following. I waive any and all claims, now and in future against, and release from all liability and agree not to sue Ron Hunter's Dive Expeditions (Lormine Pty Ltd) and its directors, officers, employees, guides, agents or representatives or licensor for any personal injury, death, property damage, or loss sustained as a result of your participation in an adventure trip with Ron Hunter's Dive Expeditions (Lormine Pty Ltd), due to any cause whatsoever, including without any limitation, negligence on the part of Ron Hunter's Dive Expeditions (Lormine Pty Ltd), its staff or licensor.

I am aware that an adventure trip, in addition to the usual dangers and risks inherent, has certain additional dangers and risks, some of which may include physical exertion for which I may not be prepared, weather extremes subject to sudden and unexpected change, remoteness from normal medical services, and evacuation difficulties if I am disabled.

I acknowledge that the enjoyment and excitement of adventure travel is derived in part from the inherent risks incurred by travel and activity beyond the accepted safety of life at home or work, and that these inherent risks contribute to such enjoyment and excitement being a reason for my participation.

I am aware that on occasions I will be in close contact with wild animals in their natural environment. Seeing and being in close proximity, as well as on occasions interacting with animals in the wild, carries with it an inherent risk. I acknowledge that I am aware of this risk and choose to undertake these wildlife encounters in the full knowledge that wild animal behaviour can at times be unpredictable.

I agree that if I suffer injury or illness, Ron Hunter's Dive Expeditions (Lormine Pty Ltd) can, at my cost, arrange medical treatment and emergency evacuation services, as Ron Hunter's Dive Expeditions (Lormine Pty Ltd) deems essential for my safety.

In entering into this agreement, I am not relying on any oral, written, or visual representations or statements by Ron Hunter's Dive Expeditions (Lormine Pty Ltd) or its staff or any other inducement or coercion to go on the adventure trip, hence, only of my own free will.

I confirm that I am over the age of 18 years, or that I am the parent or legal guardian of the traveller whom is under 18 years of age, and that I have read and understand the terms and conditions of contract and this Agreement prior to signing it and agree that this Agreement will be binding upon my or their heirs, next of kin, executors, administrators and successors. I agree that this Agreement shall be governed in all aspects by and interpreted in accordance with the law of NSW, Australia.
